#### **BACKGROUND**



Technical Advanced MP Technology is one of the world's foremost independent global distributors of electronic components, offering the benefits of

more than 30 years of experience in component distribution. The company's staff understands production goals and challenges, from factory shortages to surpluses, and develops solutions to fit each client's needs. The ISO 9001 certification is crucial for Advanced MP Technology's success because many customers require the registration. The company has been certified since 2004 and, with its 13 locations worldwide operating in sync with each other, every site needs to be accredited. A lack of certification could potentially cost the company 98% of its customers.

### **BUSINESS CHALLENGE**

James Kruthers, Global ISO Manager at Advanced MP Technology, noticed that the company's ISO registrar was not accredited through the International Accreditation Forum (IAF), one of the certifying bodies whose accreditation assures users of the competence and impartiality of a registrar. The ISO 17021 "Conformity Assessment – Requirements for Bodies Providing Audit and Certification of Management Systems Accreditation" is crucial for an ISO 9001 registrar, and Kruthers embarked on a search for a new certification provider.

## **SOLUTIONS AND RESULTS**

Seeking a Nationally Recognized Testing Laboratory with proper credentials, Advanced MP Technology interviewed four candidates and finally decided on TÜV Rheinland. The registrar's reputation for superior customer service and expertise in the management systems certification were important, as was the fact that TÜV Rheinland's offices were located in the same area as the distributor's sites seeking the certification: San Clemente, CA. Kruthers had also worked previously with TÜV Rheinland. However, the deciding factor in selecting the registrar was the efficient and timely communication with TÜV Rheinland.
