WHY DO I NEED A NATIONAL APPROVAL FOR MY PRODUCT IN SOME COUNTRIES?

Countries do not only vary in culture, language and landscape, but also in regulations. What is considered perfectly valid and safe in one country will not meet the regulations of another country. To introduce your product or service to an international market, it is imperative to have your product approved for your target country. Otherwise you could face legal claims.

WHICH ADVANTAGES DO MARKET ACCESS SERVICES HAVE TO OFFER?

This may include, but is not limited to, user instructions and labelling in the local language, or country-specific warning advises. When it comes for dedicated design- or construction requirements on a local level, those should be known to manufacturers at the earliest stage of product development. Upon an adequate description, we will inform you of all relevant standards and regulations that your product needs to comply with in one or more countries – avoiding costly changes and adaptations at a later stage.
